## Meeting the Challenges of Diabetes: Updates with the Pharmacists

**Topic:** The MCO Diabetes Performance Improvement Collaborative has launched a new three-year PIP as of 1/1/2021. The project aims to improve the comprehensive diabetes care and services for Seniors and SNBC members with the focus on closing the gaps on health care disparities within our populations. Care Coordinators/Case Managers have a vital role to educate, support, and assist members in setting and achieving health goals to improve their diabetes care.

This training is the second in a series of trainings that will be offered throughout this project that will focus on helping Care Coordinators/Case Managers better understand diabetes, its impact on persons living with diabetes, and how to best support members to best manage their condition.
